- Authorization from property owner is required (property owner may sign the ABC-221 or a signed letter showing the date, time, place and type of alcoholic beverages to be served may be submitted)

- The application must be received within ten (10) days of the event, but should not be submitted more than thirty (30) days in advance

QUALIFIED ORGANIZATIONS:

☐ To qualify for a GENERAL license, you must be:

An organization formed for a specific charitable or civic purpose, a fraternal organization in existence for five years, a religious organization, or a political organization

☐ To qualify for a BEER AND/OR WINE license, you must be:

An existing non-profit organization, including a charitable, civic, cultural, fraternal, patriotic, political, religious, social or amateur sports organization.

If this is the first time your organization is having an event, the organization must first be qualified by the Department. As proof, you should bring in IRS and/or Franchise Tax Board documents showing your tax exempt status with your tax I.D. number

POLICE DEPARTMENT APPROVAL:

- ☐ Police department approval may be required when any of the following apply:
 - · A large number of people are attending
 - The event is being held on a public street or in a public area (i.e. parking lot)
 - This is the first time an event is being held at the location
 - · The event is a "casino night"
 - The Department may require police department approval in certain other circumstances

It is the applicant's responsibility to obtain police department approval. This may be done via a letter from the police department, or the officer may sign directly on the ABC-221 form.

"BEER GARDENS"

Beer Gardens restrictions may be placed on a one-day license when the District determines there is a potential problem with the issuance of a license without such restrictions or at the request of a local law enforcement agency.

CONDITIONS:

Issuance of the permit may be subject to conditions relating to the sales, service, and consumption of alcohdic beverages. If conditions are imposed, a representative of the organization may be required to come into the ABC office to sign them.

IF ABOVE REQUIREMENTS ARE NOT MET, THE ONE DAY LICENSE MAY NOT BE APPROVED.
