RE: CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT (CAPER) FOR PROGRAM YEAR 2016 (2016-2017)

Project Description:

In accordance with a requirement of the federally-funded Community Development Block Grant (CDBG) program, city staff has prepared the annual CAPER. The CAPER contains information on performance and program accomplishments during the 2016-2017 CDBG program year. The report provides information regarding the City's expenditure of federal CDBG funds; specially addressing progress made by the City towards completion of public service activities and accessibility projects. The 2016 CAPER has been completed in compliance with federal program regulations and the City's Citizen Participation Plan. The current CAPER covers the period from July 1, 2016 through June 30, 2017 and is available for review and comment.

Public Review and Comment:

The public review period for this document is from August 24th to September 8th. During this time, the public is invited to comment.
