## UPDATED - City of Rocklin CDBG Program Notice of Annual Planning and Request for Public Comment

## Note – The time and location of the May 9<sup>th</sup> City Council Meeting has been changed. See details below.

The City of Rocklin is currently planning for the use of fiscal year 2017-18 Community Development Block Grant (CDBG) program funds. CDBG funds are made available to the City as an entitlement authorized by the Housing and Community Development Act of 1974. The City has yet to be notified of its 2017-18 award. The City expects to receive an amount roughly equal to the 2016-17 award of \$250,000. The City of Rocklin is required to submit an annual Action Plan to the federal Department of Housing and Urban Development (HUD). The Action Plan provides information on the needs of low- and moderate-income residents and eligible target areas of the City during the period between July 1, 2017 and June 30, 2018. The Plan also describes the activities that the City will undertake to meet those needs with the limited funding.

By this Notice the City is publishing the planning calendar for 2017-18 CDBG funds and providing the public with notice of opportunities for comment on the use of CDBG funds.

On March 24, 2017 the City published a Draft 2017-18 Action Plan.

The City will accept public comment on the draft Action Plan until 5:00 p.m. April 25, 2017. The draft Plan is available during normal business hours at City Hall at 3970 Rocklin Road, on the City's website www.rocklin.ca.us, and at the Rocklin public library at 4890 Granite Drive.

The City Council is scheduled to hold a Public Hearing during its regularly scheduled meeting on April 11, 2017 beginning at 6:00 p.m. in the City Council Chambers (3970 Rocklin Road) to consider the Draft Action Plan.

The City Council is scheduled to adopt the Action Plan during its regularly scheduled meeting on May 9, 2017 beginning at <u>6:00 5:30 p.m</u>. in the City Council Chambers (3970 Rocklin Road) at the Rocklin Events Center (Main Hall) 2650 Sunset Blvd, Rocklin, CA 95677.

The City will submit the Action Plan to HUD for review and approval on May 15, 2017.
