RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ROCKLIN  
DECLARING THE RESULTS OF THE  
CONSOLIDATED GENERAL ELECTION  
HELD IN THE CITY OF ROCKLIN  
ON NOVEMBER 8, 2016

WHEREAS, a Consolidated General Election was held and conducted in the City of Rocklin, County of Placer, State of California, on Tuesday, the 8<sup>th</sup> day of November, 2016, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, the County Election Department canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as Exhibit "A."

NOW, THEREFORE, the City Council of the City of Rocklin does resolve as follows:

Section 1. The whole number of votes (ballots) cast in the City was 57,253.

Section 3. The number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the office of Member of the City Council are listed in the attached Exhibit "A."

Section 4. The City Council does declare and determine that **JOE PATTERSON** was elected as Member of the City Council for the full term of four years; **GREG JANDA** was elected as Member of the City Council for the full term of four years; and **KEN BROADWAY** was elected as Member of the City Council for the full term of four years.

Section 5. The City Clerk shall enter on the records of the City Council of the City of Rocklin, a statement of the results of the election showing: (1) the whole number of votes (ballots) cast in the City; (2) the names of the persons voted for Member of the City Council; and (3) the total number of votes given to each person.

Section 6. The City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.
