1.0 INTRODUCTION

In accordance with Section 15088 of the State California Environmental Quality Act (CEQA) Guidelines, the City of Rocklin, as the lead agency, has reviewed the comments received on the Draft Environmental Impact Report (DEIR) for the Rocklin Commons Project and has prepared written responses to the comments received.

On July 27, 2009, the City of Rocklin as the lead agency released for public review the Draft EIR for the Rocklin Commons project. The Draft EIR public review period ended on September 9, 2009.

Chapter 2 of the Final EIR consists of all of the written comments received on the Draft EIR and presents responses to significant environmental issues raised in the comments (as required by the State CEQA Guidelines Section 15132). The focus of the response to comments are on the disposition of significant environmental issues raised in the comments, as specified by Section 15088(c) of the State CEQA Guidelines. Detailed responses are not provided to comment on the merits of the proposed project. However, when a comment is not directed to significant environmental issues, the responses indicate that the comment has been noted and that no further response is necessary.

Each comment letter has been reproduced and is followed by the response to comments in order of occurrence. In some instances, responses to comments may warrant modification of the text of the Draft EIR. In those cases, the text of the Draft EIR is revised and the changes compiled in Chapter 3, Corrections and Revisions to the Draft EIR. The text deletions are shown in ~~strikeout~~ and additions are shown in underline.

This document and the Draft EIR together constitute the Final EIR that is being considered by the City of Rocklin.
