#### Good to See You

#### Sierra College Contract Extension

At the first City Council meeting of February, Council approved a 120 day extension of the police services contract that started last November. The contract provides two police officers, half of a sergeant's time, records, dispatch, evidence and ancillary police services to the Campus. The contract was extended to allow City and College staff ample time to create and approve a long-term agreement.

RPD began providing contract police services to Sierra College after their police department was disbanded. The college approached RPD in mid-October with the news that they needed police service in two weeks because their police chief was leaving.

Feedback from College and City personnel has been positive and both entities desire to continue the contractual relationship.

### Now's Your Chance to Become a Rocklin Police Volunteer, by Mike Nottoli

Are you looking for a rewarding way to spend a few hours a week? Would you like to make a difference in your community?

If so, the Rocklin Police Department is looking for a few good men and women to become Rocklin Police Volunteers. The Rocklin Police Department only recruits volunteers once a year, so this is your only opportunity to become a volunteer in 2010.

Rocklin Police volunteers serve as extra "eyes, ears, and helping hands" for the police department, but do <u>not</u> engage in contacting, detaining, or arresting suspicious persons or criminals. Volunteers are not sworn officers and have no powers of arrest beyond those of any private person.

Volunteers provide a key role in helping the police department provide a high level of service to the community. Volunteers have allowed the police department to undertake programs and projects that were previously not feasible because of a lack of available resources and staff.

Rocklin Police Volunteers perform a wide variety of functions including but not limited to staffing the front counter, patrolling the city, providing traffic control at accident scenes, analyzing crime statistics, finger-printing children and adults, delivering documents and evidence, staffing special events, performing security inspections, checking homes while people are on vacation, and delivering a variety of community safety and emergency preparedness presentations in our schools, neighborhoods, and businesses.

In order to become a Rocklin Police Volunteer, you must:

- Be at least 18 years of age
- Be able to volunteer a minimum of 16 hours a month
- Be of good moral character
- Have no felony or recent misdemeanor

convictions

- Be able to work with minimal supervision
- Be able to work well with others

The volunteer hiring process requires the successful completion of a volunteer application, oral interview, background investigation, Live Scan fingerprint check, warrant check, and a volunteer academy. The Volunteer Academy is mandatory for all new police volunteers. It helps to familiarize volunteers with the different functions of the Police Department, and provides specific training to help them become safe and productive volunteers. The academy begins at 6:30 p.m. on Tuesday, August 31, 2010, and will meet on 12 Tuesday evenings and two Saturdays during the day. The Academy Graduation will be Tuesday, November 16, 2010.

Although most of our volunteers are retired, many are still raising families and working full-time jobs. Since there is no requirement to live in Rocklin, some of our Volunteers reside in Roseville, Loomis, Lincoln, and other surrounding communities.
