Police Department and Cintas representatives will be on hand at the below-listed locations and will shred up to 3 file boxes of paper at no charge:

Rocklin Location:

City of Rocklin Police Department – Main Parking Lot - 4080 Rocklin Road

Roseville Location:

City of Roseville Oak Street Municipal Parking Lot - Oak Street & Washington Blvd. There is no need to remove paper clips, staples, or file folders. You will be able to witness your documents being shredded, and you will receive a certificate stating that your documents were destroyed.

The Rocklin Police Department and Roseville Police Department invite and encourage community members to take advantage of this opportunity to shred personal documents at no charge. While the patient's current status is not known, they resuscitated the victim successfully and gave her a chance at survival. This is considered a field save and will be submitted for a Life Saving Award. Great job you guys!
