## PUBLIC HEARING NOTICE

**NOTICE IS HEREBY GIVEN** that the **PLANNING COMMISSION** of the City of Rocklin will hold a public hearing in the **COUNCIL CHAMBERS at Rocklin City Hall**, 3970 Rocklin Road, beginning at **6:30 p.m.** on **TUESDAY, NOVEMBER 5, 2024** to consider the following:

PROJECT DESCRIPTION/LOCATION – To comply with State law, each jurisdiction in California was required to update their General Plan Housing Element for the 2021 - 2029 planning period. State law also requires each jurisdiction to maintain an adequate number of sites with the development potential to accommodate housing affordable to all household income levels, known as the Regional Housing Need Allocation (RHNA). Prior to adoption of the latest Housing Element, City Council approved a list of sites to accommodate the City's RHNA obligation. This project will complete the General Plan and Zoning ordinance amendments to complete the RHNA requirements the City committed to, and to maintain compliance with State law.

The project does not trigger the need for supplemental or subsequent review under Section 15162 of CEQA Guidelines, as the proposed amendments are consistent with the goals and policies of the General Plan, and no new or substantially significant impacts are anticipated. Further, a site-specific environmental review will be required for proposed development projects on each site. Therefore, an EIR Addendum has been prepared pursuant to Section 15164 of the State CEQA Guidelines.

Any person interested in any agenda item may contact the Planning Staff prior to the meeting date, during regular business hours, Monday through Friday between 8:00 a.m. and 4:00 p.m., or by phoning (916) 625-5100 for further information.
