NOTICE IS HEREBY GIVEN that the **PLANNING COMMISSION** of the City of Rocklin will hold a public hearing in the **COUNCIL CHAMBERS at Rocklin City Hall**, 3970 Rocklin Road, beginning at **6:30 p.m.** on **TUESDAY, AUGUST 6, 2024** to consider the following:

This application is a request for approval of a Design Review (DR2023-0014) to facilitate the phased development of a 96,000-square-foot health center, offering medical, dental, optometry services, related administrative functions, and a pharmacy on a 13.1-acre parcel.

The subject site is located on the northwest corner of West Stanford Ranch Road and Wildcat Boulevard. The Assessor's Parcel Numbers (APN's) are 378-010-015, -014, and -013.

The property is zoned Planned Development Business Professional/Commercial/Light Industrial (PD-BP/C/LI). The General Plan designation is Business Professional/Commercial/Light Industrial (BP/COMM/LI).

Notice is hereby given that the City of Rocklin will consider adoption of a Mitigated Negative Declaration for the development project described above. **The review period for the Mitigated Negative Declaration begins on July 13, 2024 and ends at 5:00 p.m. August 1, 2024.** The environmental document is available for review during normal business hours at the City of Rocklin Community Development Department, Planning Division, located at 3970 Rocklin Road, Rocklin, CA 95677 and online at <http://www.rocklin.ca.us/depts/develop/planning/currentenvirodocs.asp>. The applicant is Jack Williams with JAX Construction, Inc. The property owner is Chapa-De Indian Health Program, Inc.
