## Message from the Chief by Mark Siemens

#### Gun Safety

As police officers, part of our job on and off-duty is the protection of those around us. The last thing we would ever want is to cause harm because of our job. Just recently, a Sutter County Sergeant experienced an unthinkable tragedy when his three-year-old son picked up his father's duty weapon and fatally shot himself in the head. The sergeant and his wife were standing only feet away when this happened. The gun was only left unattended for seconds, but there is absolutely nothing that can fix the consequences of those few seconds.

Police organizations are gun

cultures. We handle and carry firearms every day. Sometimes we forget the real weight of being constantly armed. In every situation, we must think about the security of our weapons, especially in our own homes when we have children or visitors.

Here at Rocklin Police Department we issue gun safes with our duty weapons to provide a safe storage option for our handguns. Please use them. I cannot imagine the pain that is and will be felt by Sergeant Whiteaker and his family. The stakes are very high and sobering. A few second lapse of gun control cost a child's life and forever changed many others.

The fifth annual Volunteer Appreciation Dinner was held Friday, April 11<sup>th</sup> at the Sunset Center. This year's event honored the department's 101 police volunteers for their hours of service during the past year. In 2007 volunteers logged 10,542 hours saving the city approximately \$196,800. We are well on our way of exceeding that number for 2008. Volunteers received pins noting their individual hours of service and a Presidential service award certificate from President George W. Bush. Rich Vallone and Frank Yoschak were among the volunteers that logged the highest

total hours with approximately 1500-1800 hours of total service to the community.

The volunteer program began in 2002 with only four volunteers. We currently have 101 volunteers with a new Academy of 25 starting in September 2008. Volunteers provide a service to our community and the police department that is far more valuable than just dollars and cents. They are trained and work tirelessly in specialized fields of interest providing services to the community that may not be offered without such a robust and successful program.

The day started with the Kings organization hosting a law enforcement basketball tournament and included a display of police cars and motorcycles.

The Rocklin Police Department Honor Guard participates in different events each year including the California Police Memorial events, the Placer County Law Enforcement Awards Banquet, and funerals for peace officers.

#### New Alarm Ordinance goes into Effect, by Sgt. Terry Roide

As of April 11th, 2008, our new Alarm Ordinance became law. In 2006 and 2007, we responded to over 2,700 false alarms each year. These false alarms accounted for over 10% of all of our calls for service in 2007 and we spent over 1,500 hours of Officer's time. The Alarm Ordinance requires that any person or business which activates, operates, or maintains an alarm system upon any premises in the City of Rocklin needs to obtain an Alarm Permit. The permits are \$25 for the first 2 years and

\$15 for each two year renewal. The Ordinance allows a grace period to September 1st, 2008, for residents and businesses with existing alarms to obtain a permit. Alarms are classified as either General/Burglar or Holdup/Duress. Residents and businesses that experience a second alarm in a rolling 12 month period, based on the date they obtained their permit, will be charged \$50 for a General/ Burglar alarm and \$100 for a Holdup/Duress alarm. On their third and subsequent alarms in the 12 month period, they will

be charged \$100 for each General/Burglar alarm and \$150 for each holdup/Duress alarm. One of the goals of our new Alarm Ordinance is to lower the amount of False Alarm calls and free Officers to respond to other calls for service or proactive activity. The permit process will also ensure that we have accurate information for each alarmed residence and business regarding responsible information.
