Several years ago, we added two Senior Public Safety Dispatchers as a step toward a full-time supervisor. As you know the Senior PSDs still work the console and rarely have time to dedicate toward supervision. Unfortunately, our growth stopped and the next step of adding a supervisor to dispatch did not materialize.

In my meetings with dispatch staff earlier this year, the #1 issue on their wish list was a fulltime supervisor. With the outlook for near-term growth dim, we have looked at our current staffing levels and determined that we may be able to promote a supervisor from our current non-sworn ranks and improve the operation. Since we are just in the process of hiring a replacement for the vacant Records-Communication Manager, we intend to appoint an acting communications supervisor initially.

The City Council will see the position for approval about the time you read this article. Now all that is left is the selection process, which Captain Lawrence is developing. FBI National Academy by Lieutenant Lon Milka

I recently attended and graduated from the FBI National Academy and thought that I'd let you know what it is all about.

The physical grounds of the FBI National Academy, in which the FBI Training Academy is located, are within boundaries of the Marine Corps Base at Quantico, Virginia. The academy is made up of a maze of intertwined buildings that are seemingly perpetually under renovation. A series of "gerbil tubes" connect the dorms, library, auditorium, gymnasium, chow hall, and class rooms.

The academic foundation of the FBINA consists of courses accredited by the University of Virginia. These fall within distinct disciplines of study such as, Behavioral Science, Leadership Development, Law, and Forensic Science. For 10 weeks students attend 5 undergraduate and graduate courses in various locations throughout the facility. The instructors are active special agents, retired law enforcement, or military officers.

The physical training component includes instruction on nutrition, aerobic and anaerobic exercise regimens, and, of course, actual physical training with your "section" (or regular group) of about 42 other classmates. This includes the path to "yellow brick road" which includes Wednesday physical challenges in which the entire class participates

together.

The social networking part of the FBINA is perhaps its cornerstone. Class #241 consisted of 260 participants from 49 states, the District of Columbia, and 25 foreign countries. We had time to learn from each other and to learn about different parts of the world.

One of the most memorable and consistent experiences of any FBINA class was the food in the cafeteria. The ambitious workers in the cafeteria make several hundred meals at just about each setting; that's 3 meals a day, 365 days a year. They make meals for the National Academy students, the FBI new agent trainees, FBI analyst trainees, those participating in in-service training, and staff. I mentioned that the food was consistent. I will leave your imaginations run wild on that statement!

Some personal notes:

- I very much enjoyed seeing a part of the country that I had never been to. I visited NYC, Philadelphia, Gettysburg, and Annapolis to name a few places.
- I had a great roommate who is from

Elizabethtown, Kentucky. My suitemates (yes, 4 of us shared a bathroom) were from West Virginia and Tennessee. So, it wasn't long before I said my first, "Y'all," during a normal sentence.

Rocklin Police and Sierra College Security Join Forces to Manage a Student Intern Program by Sergeant Chad Butler

For several years, Sierra College and the Administration of Justice program have been entertaining the idea of offering a Law Enforcement Internship to their students. After we were contracted to provide law enforcement services, Sierra College approached us and asked if we were interested in participating in this program along with Sierra College Security. We jumped at the idea and began putting the plans in motion.

Beginning with the Fall of the 2010 semester, Administration of Justice majors with a minimum of 20 semester units are invited to apply for the program. Student participants will be re-

quired to submit an application, pass an oral board and submit to a thorough background investigation.

Successful candidates will have the opportunity to learn, from our employees, the full spectrum of law enforcement to include: Records Management, Property and Evidence maintenance, Public Safety Dispatching, Crime Scene Investigation, Detective/ Investigations, and general Patrol policing. In addition, student interns will also be exposed to security procedures by assisting Sierra College Security staff with parking citations, safety escorts and traffic

control to name a few examples.

We are getting closer and closer to our onsite assessment by CALEA staff for our reaccreditation. When we started this endeavor several years ago, there was a lot of skepticism surrounding the accreditation process and the end result. Having been exposed to the inner workings of this organization for over a year now, I can say with utmost certainty that accreditation is important, and it is one of the reasons behind our organizational success today.

During the file maintenance process of CALEA we are constantly holding ourselves accountable. We do what we say we will do and we scrutinize our policies and procedures. We check and double check that our equipment is up to date, functional, and operationally ready. Would we really do this without the file maintenance system that is the backbone of accreditation? I would like to think so. The accreditation process has really become how we do business everyday. We are light years ahead of where we would have been without this process.

A police officer's job is not easy. In fact, it is one of the most difficult jobs in the world. What other profession needs to

wear so many hats? Police officers must be walking law encyclopedias. They must be highly trained in their craft of keeping the streets safe.
