#### Shut Up and Drive!

July 1, 2008, is the date that Californians must change the way we use cell phones; a change that will not be easy for any of us. Two new laws take effect that I am certain will not be popular to the many yakkers on the roadway.

## Responsible Host Program, by Mike Nottoli

On April 29th, representatives from all local Placer County law enforcement agencies conducted a press conference at the Roseville Police Department to officially announce the establishment of the Responsible Host Program. Rocklin Police Chief Mark Siemens kicked off the press conference which was well attended by program supporters and local television. radio, and print media representatives.

The theme of the Responsible Host Program is simple and straight forward: "parents who host lose the most." The Responsible Host Program provides parents with excellent information about the perils of hosting or knowingly allowing alcohol/drug related underage parties to occur in their homes. The information comes in many forms including a tip sheet for hosting safe parties,

guidelines for letting kids attend parties elsewhere, the penalties for furnishing alcohol to minors, and the health consequences of underage drinking.

Most importantly, the program establishes the creation of a county-wide data base where parents can register their dwelling as a "Responsible Host" residence. As a "responsible host", parents sign and agree to abide by the following pledge:

- 1. I will not allow parties in my home when I am not present.
- 2. I will be an active chaperone at parties in my home.
- I will not serve, nor willingly allow, minors to consume alcohol or illicit drugs in my home or on my property.
- 4. I will welcome parents/guardians of youths attending a party at my home to call and check on party details, times, supervision, and/or any other concerns.
- 5. I will not hesitate to call a parent/guardian if a problem arises with their youth in my home.
- I will encourage my son/daughter to only attend parties at addresses listed on the Responsible Host data base.
- 7. I will monitor and control the number of people who attend parties at my home. I will call the police if the party gets out of hand or if uninvited guests refuse to leave.
- 8. I will discuss with my son or daughter the ramifications of advertising or posting party information on the Internet or any other medium.

When a parent(s) signs a pledge and submits it to their local law enforcement agency, the information is stored in a data base. Persons wishing to find out whether a particular home is a "Responsible Host" residence can log onto:

and can type in either the address or phone number of a residence. So far, 286 people have submitted pledges and applications and now have their residences listed on the website.

It is our sincerest hope that this program helps parents and young people avoid the pitfalls of alcohol-related parties. Please take the time to check out the new website and take advantage of the valuable information.

# Rocklin Adds a New Red Light Camera, by Sgt. Terry Roide

In an effort to reduce collisions and make city streets safer, the Rocklin Police Department added a new intersection to the Red Light Photo Enforcement Program. On June 6th, 2008, cameras and violation sensors that monitor the intersection of Rocklin Road and Interstate 80 became operational. The cameras will monitor both straight through lanes and the left turn lane for W/B Rocklin Road traffic at the on-ramp and off-ramp

from W/B Interstate 80.

The program is seen as an important step to improve

the safety and flow of local traffic. The Rocklin Police Department is giving driv-



ers a 30-day warning period at this intersection before actual citations are issued, during which time we will issue only Warning Notices. The Notices will explain that beginning July 7th, 2008, actual citations will be sent to violators, who will then be responsible for paying the fine listed on the citation.
